## **GEORGIA CITIZENS HAVE ACCESS TO SEVERAL CONVENIENT METHODS OF REGISTERING TO VOTE:**

### **Online:**

Visit [www.mvp.sos.Ga.gov](http://www.mvp.sos.Ga.gov). You must have a valid Georgia Driver's License to use this service. Once you have submitted your registration, it will arrive on the Paulding County Election Dashboard the next morning for processing.

### **Paper Application:**

Voter Registration Applications are available in the local Elections Office, Tax Commissioners Office, Tax Assessors Office, County libraries, municipalities, and public assistance agencies. To download a paper form, please go to [www.paulding.gov/216/Elections-Voter-Registration](http://www.paulding.gov/216/Elections-Voter-Registration).

Registration is offered when you renew or apply for your driver's license at Department of Driver Services.

## **TO REGISTER TO VOTE IN THE STATE OF GEORGIA, YOU MUST BE:**

- A citizen of the United States
- A legal resident of Georgia and of the county in which you wish to vote
- Be at least 17 ½ years of age to register and 18 years of age to vote
- Not be serving a sentence for conviction of a felony involving moral turpitude
- Have not been found mentally incompetent by a judge

## **ABSENTEE VOTING BY MAIL**

Any voter registered in Georgia may vote absentee by mail by going to [absenteerequest@paulding.gov](mailto:absenteerequest@paulding.gov) to request an application or calling the Elections Office at 770-443-7503. Mail-in ballots can be requested no earlier than 78 days prior to the election and must be received by your county registrar no later than close of the polls on Election Day.
